**Page 3: Academic Calendar-Spring Semester 2025**

Update the following dates:

**Page 23: Admission of Undocumented Immigrant Applicants**

Effective November 1, 2024. Change first paragraph to read:

Pursuant to the State Board of Community College Code 1D SBCCC 400.2(b)(1), James Sprunt Community College will accept for admission undocumented, non-immigrant applicants who have earned a High School Equivalency Diploma (formerly GED), or attended and graduated from a United States public high school, Adult High School, private high school, or home school that operates in compliance with State or local law. Undocumented immigrant applicants do not qualify for in-state tuition and shall be charged at the out-of-state tuition rate for curriculum programs

**Page 30: Tuition and Fees**

Transcript Fee should be changed to \$6.00.

**Page 44: Veterans Education Assistance**

Add the following new section after **Satisfactory Academic Progress for Veterans** section:

**Service Member Disclosure**

To eliminate deceptive marketing practices aimed at service members and their dependents, James Sprunt Community College and its employees will abstain from: a) providing any commission, bonus, or other incentive pay, b) high-pressure recruitment tactics, including unsolicited email and phone correspondences to service members and their dependents.

James Sprunt Community College is committed to compliance with Principles of Excellence standards set by the US Departments of Education, Defense, and Veterans Affairs. The College is also committed to compliance with the NC Community College Code related to the enrollment of military reserve and National Guard

personnel who receive temporary or permanent reassignments due to military operations that make it difficult or impossible to complete their studies.

Students should make appropriate notifications as soon as they become aware of orders that will interrupt their studies. A copy of those orders is required before any accommodations can be completed. Military students seeking to complete courses within the term or semester should contact each of their instructors and/or the Curriculum Dean to request accommodations. Service members may also receive immediate readmission into their program of study after active-duty service. Students seeking readmission for another semester or term should contact the Vice President of Student Services for support and help.

**Page 53: Curriculum Transcripts**

Remove the following sentence from first paragraph: Transcripts will be withheld until all student obligations to the college are completed (Business Office Hold, Financial Aid Hold, or Library Hold). Transcript Fee should be changed to \$6.00.

**Page 186: Workforce Development/Continuing Education-Transcripts**

Transcript fee should be changed to \$6.00.
